Do you need a caregiver?

This program is designed to help elderly and disabled individuals by providing them with skilled and compassionate caregivers who will provide them with quality personal in-home healthcare. As a recipient, you are also able to be involved with hiring your own personal caregiver. Personal care attendants may be a friend, family member, neighbor, or anyone you feel you can trust to provide you with quality care. The goal of this program is to provide the highest quality of in-home healthcare all in the comfort of your own home.

Consumer-Directed

The **Consumer-Directed** model is designed to allow the consumer to “direct” the delivery of their own personal care services. The consumer is able to recruit and select their own care attendant. They have total control of their personal care and can supervise their attendant as well as set and monitor their care attendants schedule. They also have the ability to terminate the care attendant if they are not pleased with the delivery of services. Intelli-Care works with the consumer and helps to coordinate all business related responsibilities assuring the consumer is happy with all aspects of their personal care services.

Consumers are able to select one of the two different models of service for their personal care services.

- Consumer-Delegated model

Consumer– Delegated

The **Consumer-Delegated** model is designed for the consumer to “delegate” the delivery of services to Intelli-Care LLC as their approved personal care provider. Intelli-Care is responsible for recruiting, interviewing, hiring, supervising, training and terminating their personal care attendant or caregiver. When the consumer elects the Delegated model he or she is giving up the control of being able to direct their own care and are putting it in the hands of their provider agency. With this model the agency has a lot more responsibility and is required to do monthly supervised visits in the residence. The supervised visits can be scheduled visits or unscheduled visits as long as it is during the consumers normal scheduled hours.
